



CMCA CRAZY CARTS WAIVER FORM 2024

I understand that this activity is dangerous and may become more hazardous or dangerous during the time I am on the premises of CMCA, that the risk of injury from the operation of a KART is significant, including the potential for serious bodily injury, paralysis and death; that I am aware of all the risks and hazards inherent with my operating a KART at CMCA and hereby voluntarily assume all risk of loss, damage and injury, including death, that may be sustained by me or any property of mine while at CMCA.

In consideration of renting and operating any Razor Crazy Kart (KART), I hereby release Canyon Meadows Community Association (CMCA), its members, directors, employees, successors or assigns, from any and all liability, claims demands, actions, and causes of action whatsoever, whether foreseen, arising out of or related in any way to my renting and operating a KART at CMCA that may result in injury, death or property damage or loss or other damages to me or my family, estate, heirs, or assigns, and further to save and hold harmless to CMCA, its members, directors, employees, successors or assigns, from all liability whatsoever for personal injury, property damage or loss or wrongful death caused by its negligence. This release shall be binding upon my family, estate, heirs, or assigns. This release shall continue in effect each time I rent and operate a KART at CMCA. CMCA may utilize photographic, video or other images of myself for subsequent advertising and promotion purposes without any fee or consideration to myself.

In signing the foregoing Liability Release, I acknowledge and represent that:

- A. I have read the foregoing Liability Release, understand it, and sign it voluntarily.
- B. I am at least able to reach the peddle.
- C. I am not pregnant.
- D. I have not consumed alcohol or drugs, which may affect my ability to drive a go-kart in a safe manner.
- E. I do not suffer from a heart condition, high blood pressure or other medical condition which may be aggravated by my operating a KART.
- F. If I am under 18 a helmet while operating a KART is mandatory, which will not be supplied by the CMCA.
- G. I will obey all rules and regulations of CMCA, and I will closely observe and follow the instructions of all facility personnel.
- H. This agreement is continuing and shall remain in effect every time I use this facility.
- I. If I am under 18 years old, I must have my parent or legal guardian sign this form, and they will make sure I bring a helmet.
- J. I must view the safety Briefing materials prior to racing.
- K. I cannot wear open toed shoes, sandals, or heels.
